ORDER

The undersigned is directed to inform that some modification/addition to the provisions of existing BEUP Guideline, 2019 was under active consideration of the Government for the sometime past

After careful consideration of the matter, the undersigned is directed by order of the Governor to say that the Governor has been pleased to accord approval to the following modification/addition to the provisions of existing BEUP Guideline, 2019 under Bidhayak Elaka Unnayan Prakalpa (BEUP) with immediate effect:- (i) Para 2.7 of the Bidhavak Elaka Unnavan Prakalpa Updated Guideline shall be read as "The scheme should be checked whether it is in conformity with these guidelines before sending it to the implementing agencies for processing. The Commissioner, KMC/ Sabhadhipati or District Magistrate who are Sanctioning Authorities for the Prakalpa within their respective jurisdiction will give administrative approval and financial sanction against duly vetted estimates only. They will get the detailed schemes prepared on the basis of the recommendations received from the MLAs and duly vetted by the appropriate authority before according administrative approval and financial sanction for the schemes. For delegation of financial power of tender acceptance and vetting schemes under BEUP Finance Department's Memorandum No. 30-F(Y) dt. 05.01.2021 is to be followed."

"The scheme should be checked whether it is in conformity with these guidelines before sending it to the implementing agencies for processing. The Commissioner, KMC/ Sabhadhipati or District Magistrate who are Sanctioning Authorities for the Prakalpa within their respective jurisdiction will give administrative approval and financial sanction against duly vetted estimates only. They will get the detailed schemes prepared on the basis of the recommendations received from the MLAs and duly vetted by the appropriate authority before according administrative approval and financial sanction for the schemes. The P&RD Department's circular No. 3969- PN/U/FP-1/5 dt. 25.7.06 regarding delegation of financial powers in respect of 3 tiers Panchavats for execution of different schemes is to be followed. Schemes of Rs. 10 lakh or more are to be executed by Zilla Parishads. Schemes having cost or estimate of more than 2 lakh but less than 10 lakh are to be executed by Panchayat Samities. Remaining scheme costing up to Rs. 2 lakh may be executed by Gram Panchayat Samities. However, in special cases, the Zilla Parishads may get the schemescosting more than Rs. 10 lakh executed by Panchayat Samities.Similarly,Panchayat Samities may get the schemes having costestimates of more than Rs. 2 lakh but less than Rs. 10 lakh executedby the Gram Panchavats "

This will be incorporated in the BEUP Guidelines in due course. This order issues with the approval of the Additional Chief Secretary of this Department.
